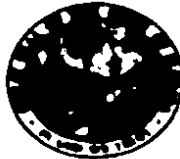

ARTICLES OF INCORPORATION OF COASTAL UNDERWATER SALVAGE COMPANY

I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by the virtue of the laws of the State of Florida under the following proposed charter:

ARTICLE I - NAME / ADDRESS

The name of the corporation shall be COASTAL UNDERWATER SALVAGE COMPANY, and its business shall be carried on in the State of Florida and such other states and countries as may be agreed upon, and its principal place of business shall be 7042 Grand Boulevard, 2nd Floor, New Port Richey, Florida 34452, or such other place as from time to time is designated.

ARTICLE II - DURATION

The term and duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The primary purpose of the corporation shall be to inspect, photograph, salvage and or provide technical reports under the waters within the State of Florida, in the waters of the United States, and international waters. This corporation shall be authorized and permitted to engage in any activity of business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The total number of shares that may be issued by the corporation is 10,000 shares of common stock, with a par value of \$1.00 per share. Said stock shall be paid for in such a manner as the Board of Directors may provide and approve, whether in cash, services or property.

ARTICLE V - OFFICERS AND DIRECTORS

The business and affairs of this corporation shall be conducted and managed by a Board of Directors of not more than (3) members, as may be by the corporation provided, who shall be elected annually by the stockholders of the corporation at such time and place as may be fixed by the by-laws or by resolution of the Board of Directors, and who shall hold office until their successors shall be elected and qualified. The names and addresses of the initial officer and director who is to serve until the first annual meeting of the stockholders is as follows:

ARTICLE VI - INCORPORATOR

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and Shareholders.

ARTICLE VIII - POWERS

This corporation shall have the corporate powers enumerated in the Florida General Corporation Act as now pending or hereafter enacted.

ARTICLE IX - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholder(s) is subject to this reservation.

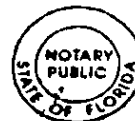
