**ARTICLES OF INCORPORATION**

**OF**

**DK GRAPHICS, INC.**

**ARTICLE I**

The name of the corporation is DK Graphics, Inc. (hereinafter called the "Corporation"), and the address of the principal office and the mailing address of the Corporation is 212 N.W. 118th Drive Coral Springs, FL 33071.

**ARTICLE II**

This corporation may engage in any business permitted under the laws of the State of Florida.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
