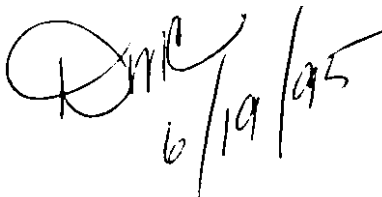

The undersigned subscriber to these articles of incorporation, being duly licensed to practice medicine in the State of Florida pursuant to the laws of the State of Florida, adopts these articles to form a professional association under the Professional Service Corporation Act, Chapter 621, Fla. Stat. (1993), and other laws of the State of Florida.

EFFECTIVE DATE

ARTICLE I - NAME AND ADDRESS

The name of the professional service corporation is David A. Alanis, M.D., P. A. and the mailing address of the corporation is 5500 North Davis Highway, Pensacola, Florida 32503.

ARTICLE II - DURATION

This professional association shall exist perpetually commencing upon July 1, 1995.

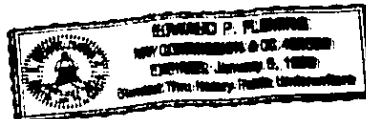
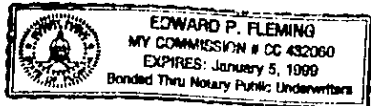
