The undersigned, incorporator (s) of these Articles of Incorporation, each a natural person competent to contract, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is:

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE






