The Incorporator named herein does hereby subscribe to and file these Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act.

**ARTICLE I
NAME**

The name of this Corporation is:

**ARTICLE II
PURPOSE**

This Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act. More specifically, this corporation is formed for the primary purpose of developing, monitoring and evaluating quality assurance programs and to prepare proposals pursuant to the various request for proposals that are developed by various state, federal and local agencies and private foundations for various health care organizations. 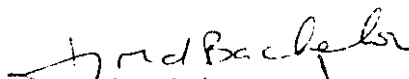

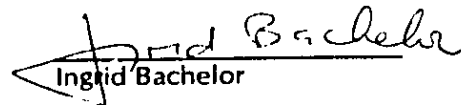
