ARTICLES OF INCORPORATION
TANELORN, INC.

Article 1. Name. The name of the corporation is:
TANELORN, INC.

Article 2. Principal Office. The principal office of the corporation shall be located at: 8253 Quail Hollow Blvd. Wesley Chapel, FL 33544

Article 3. Stock. The number of shares the corporation is authorized to issue is one thousand (1000). There shall be one class of shares, which is common, and each share shall have a par value of (.10). The rights of each shareholder shall not vary as to relative rights and preferences among shares. The corporation elects to have preemptive rights.
