ARTICLES OF INCORPORATION OF



CHRISTOPHER FRANK, ARCHITECT, P.A.

'The undersigned, for the purpose of forming a corporation under Chapter 621, Florida Statutes, also known as the "FROFESSIONAL SERVICE CORPORATION ACT", hereby adopts the following Articles of Incorporation:

ARTICLE 1 - NAME AND ADDRESS

The name of this corporation is CHRISTOPHER FRANK, ARCHITECT, P.A.. The address of this corporation shall be 120 Canal Street, New Smyrna Beach, Florida, 32168.

ARTICLE 2 - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE 3 - PURPOSE

ARTICLE 4 - CAPITAL STOCK

This corporation is authorized to issue 500 shares of "Voting Common Stock" and 500 Shares of "Non-Voting Common Stock", all with no par, and except for the voting rights, all shares shall be identical.

ARTICLE 5 - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 6 - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE 7 - IMITIAL BOARD OF DIRECTORS

This corporation shall not engage in any business other then the rendering of the professional services for which it was specifically incorporated, but it shall be permitted to invest its funds in real estate, mortgages, stocks, bonds or any other ype of investment, and shall be permitted to own any real or personal property necessary in the rendering of professional services.

ARTICLE 12 - LICENSED OFFICERS AND EMPLOYEES

Any officer, shareholder, agent or employee of this corporation shall, upon becoming legally disqualified to render such professional service within the State of Florida for which this corporation was organized, or accepts employment that pursuant to existing laws places restrictions or limitations upon his continued rendering of such professional services, shall sever all employment with, and financial interest in, this corporation.

ARTICLE 13 - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent provided by law.

ARTICLE 14 - AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
