



ARTICLES OF INCORPORATION
of
LIVE WIRE COMMUNICATIONS, INC.

Article I

Name. The name of the Corporation is LIVE WIRE COMMUNICATIONS, INC.

Article II

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution of these Articles.

Article III

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and the State of Florida.

Article IV

Capital Stock. This Corporation is authorized to issue ONE HUNDRED (100) shares of One Dollar (\$1.00) par value common stock.

Article V

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and shareholders.

Article VI


Article VII
