**ARTICLE I**

**NAME**

THE NAME OF THIS CORPORATION IS S.U. BANQUET SERVICES, CORP.

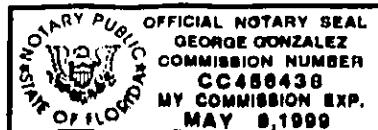

