ARTICLES OF INCORPORATION FOR PROFESSIONAL CORPORATION OF ASSOCIATED THERAPY SERVICES, S. P., P. A.

The undersigned natural person, competent and licensed to practice speech therapy in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be ASSOCIATED THERAPY SERVICES, S. P., P. A.

The principal office of this corporation shall be 1326 Lewis Turner Blvd., Ft. Walton Beach, Florida 32548.

The mailing address of this corporation shall be 1326 Lewis Turner Blvd., Ft. Walton Beach, Florida 32548.

ARTICLE II

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of speech therapy, and all its fields of specializations, as are engaged in by speech therapists.
- b. To engage and render the professional services involved only through its officer, agent and employee who shall be a speech therapist in good standing and duly licensed or otherwise legally authorized within the State of florida to render the same professional service

as this corporation.

The corporation shall have a Board of Directors consisting of one person. The number of Directors may be increased or decreased from time to time by a resolution of the Stockholder but shall never be less than one. The name and address of the initial Director of this corporation are:

ARTICLE VIII

Any action of the Shareholder may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by the Shareholder entitled to take such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

ARTICLE IX

If the officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on her continued rendering of such professional services, she shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation

on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay her all amounts owing and lawfully due to her by the corporation, except that such shares shall not be entitled to dividends.

ARTICLE X

If the Director severally or collectively consents in writing to any action taken or to be taken by the corporation, and the writings evidencing his consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XI

The corporation shall indemnify any officer or director, or any former officer of director, to the full extent permitted by law.

ARTICLE XII
