**ARTICLES OF INCORPORATION
OF
PARTY CITY OF PANAMA CITY, INC.**

ARTICLE I

The name of this corporation shall be **PARTY CITY OF PANAMA CITY, INC.**

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose of this corporation shall be to engage in the business of selling party goods to the general public.

ARTICLE IV

The amount of capital stock authorized shall be one thousand (1,000) shares of common stock having a par value of One dollar (\$1.00) per share, making a total authorized capital stock of one thousand dollars (\$1,000.00).

ARTICLE V

The street address of the corporation's initial registered office is 1600 East 12th Street, Lynn Haven, Florida 32444. 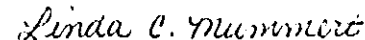
