ARTICLES OF AMENDMENT OF SUN HOLIDAYS, INC.



- 1. The name of the Corporation is SUN HOLIDAYS, INC. (the "Corporation").
- 2. Article III of the Articles of Incorporation of the Corporation is hereby amended to read as follows:
