ARTICLE I - NAME

The name of this corporation is ECO CONCEPTS, INC. The mailing address of the corporation shall be Post Office Box 335, Orlando, Florida 32825.

ARTICLE II - DURATION

This corporation shall exist as long as it can.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

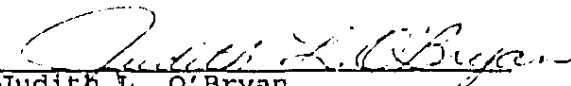
