# ARTICLES OF INCORPORATION

OF

#### ARTICLE I - NAME

The name of this corporation shall be:

CHC FINANCIAL CORP.

(hereafter referred to as the "Corporation").

EFFECTIVE DATE

#### ARTICLE II - ACTIVITIES
