ARTICLES OF INCORPORATION OF MEDICAL EDUCATION CONSULTANTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under Rec Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I

The name of this Corporation shall be Medical Education Consultants, Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

Article III

The general nature of the business to be transacted by this Corporation is any and all business permitted under the laws of the State of Florida.

This Corporation shall commence upon the filling of these Articles of Incorporation, and shall have perpetual existence.
