ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **KITO, INC** and its principal place of business shall be located at **11 ISLAND AVENUE, APARTMENT 905, MIAMI BEACH, FLORIDA 33131.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE - CAPITOL STOCK

This corporation is authorized to issue five hundred (500) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares."

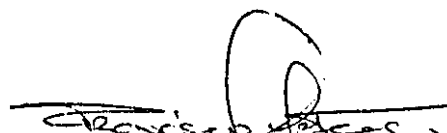
