I, the undersigned, being of legal age and a natural person; do hereby subscribe to, acknowledge and file the following Articles, of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# ARTICLE I

The name and initial address of this Corporation shall be: RELIABLE HOME IMPROVEMENTS, INC., 6530 Boca Del Mar Drive, Apt. #132, Boca Raton, Florida 33433.
