ARTICLES OF INCORPORATION

ARTICLE I - NAME

JEBBE Investment Club, Inc. Principal place of Business and mailing address: 9661 NW 39th Court, Cooper City, FL 33024.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

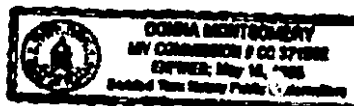
