The following shall constitute the Articles of incorporation organizing a corporation under the laws of Florida.

Article One

The name of the corporation is: **AMERICAN DYNAD CORPORATION**

Article Two

The duration of this corporation is perpetual. The corporate existence of this corporation shall commence on the date these Articles of Incorporation are executed

Article Three

The general purpose for which this corporation is initially organized is: Advertising Sales

This corporation may also engage in the transaction of any or all lawful business for which corporations may be incorporated pursuant to Chapter 607, Florida Statutes.

Article Four

The aggregate number of shares which the corporation is authorized to issue is 50 shares of common stock, with a par value of \$ 10.00 per share.

The stockholders of this corporation shall not be accorded any pre-emptive rights to subscribe for additional shares of the capital stock of this corporation.

The initial Board of Directors shall consist of one person, whose name and address is: Chet Leslie 961 S.W. 68th Avenue Plantation, Fl. 33317

The number of directors of the corporation shall be fixed by the By-Laws.

Article Eight

The Name and address of the incorporator of this corporation is: Mark Leslie, 961 S.W. 68th Avenue Plantation, Fl. 33317

Article Nine

The corporation shall indemnify any and all of its directors or officers or former directors or officers, or any person who may have served at its request as a director or officer of another corporation in which it owns shares of capital stock, or of which it is creditor against the expenses actually and necessarily incurred by them, in connection with the defense of any action, suit or proceedings, in which they or any of them are made parties, or a party by reason of being or having been directors or officers, or a director or officer of the corporation, or of such other corporation, except on relation to matters as to which any such director be adjudged in such action, suit or proceeding, to be liable for negligence or misconduct in the performance of his duties. Such indemnification shall not be deemed exclusive of any other rights to which those indemnified may be entitled under the By Laws, agreements, vote of stockholders, Chapter 607, Florida Statutes, or otherwise.

No contract or other transaction between the corporation and any other corporation in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the directors or the corporation is or are interested in, or is a director or officer or are directors or officers of such other corporation, and any director or directors, individually or jointly, may be a party or parties to, or may be interested in such contract or transaction of the corporation or in which the corporation is interested. No contract, act or transaction of the corporation with any person or persons, firm or corporation with any person

or persons, firm or corporation in the absence of fraud, shall be affected or invalidated by the fact that any director or director of the corporation is party or are parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm or corporation. Each and every person who may become a director of the corporation is hereby relieved from any liability that might otherwise exist from thus contracting with the corporation for the benefit of himself or any firm association or corporation in which he may be in any way interested. Any director of the corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he also is a director of such subsidiary or controlled company.
