# ARTICLES OF INCORPORATION OF ADVANTAGE INVESTMENTS, INC.

# ARTICLE I - NAME

The name of the corporation is ADVANTAGE INVESTMENTS, INC.

# ARTICLE II - DURATION

This corporation shall exist for a period of perpetuity.

## ARTICLE III - PURPOSE
