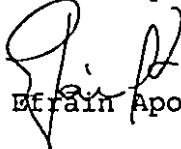

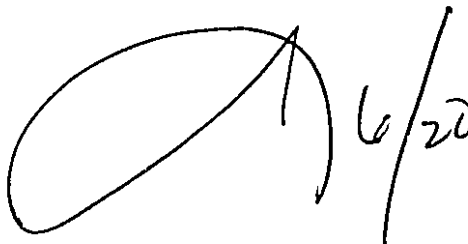

ARTICLES OF INCORPORATION
OF
ROGER ALLEN LEIBIN & ASSOCIATES, INC.

ARTICLE I - NAME

The name of this corporations is ROGER ALLEN ASSOCIATES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date these Articles of Incorporation are filed in the Office of the Secretary of State, State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business relating to architectual services.

ARTICLE IV - CAPITAL STOCK

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

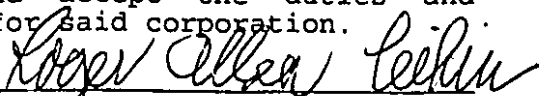
ARTICLE XIV - AMENDMENT

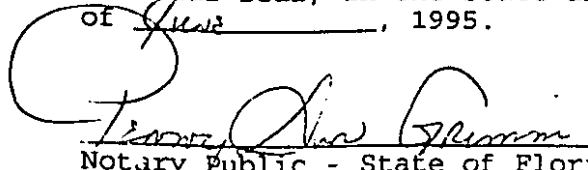
