ARTICLES OF INCORPORATION
OF
PRECISE MARKETING CONCEPTS, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, do hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be PRECISE MARKETING CONCEPTS, INC.

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida and the corporation shall have the power and authority to do any and all things to the same extent as natural persons might or could do in any place whatsoever.

It is the intention that the powers and nature of the business of this corporation shall not in any wise be restricted or limited except by operation of law and the corporation shall have the

powers as may be granted either now or hereafter to corporations by the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to distribute is one hundred (100). Such shares shall be of a single class of common stock and shall have a par value of One Dollar and No/100 (\$1.00) per share.

ARTICLE IV

DURATION

The general purpose corporation shall have perpetual existence.

ARTICLE V

PRINCIPAL OFFICE

ARTICLE VI

REGISTERED AGENT

In pursuance of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

This corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

DISSOLUTION

This incorporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (1) of the affirmative vote of the holders of at least one-half (1/2) of the outstanding shares of the corporation entitled to vote thereon.

ADDITIONAL SHAREHOLDERS AND WITHDRAWALS

The provision for additional shareholders and withdrawal of shareholders of this corporation shall be provided in the By-Laws.

ARTICLE XIII

SALE OR TRANSFER OF STOCK

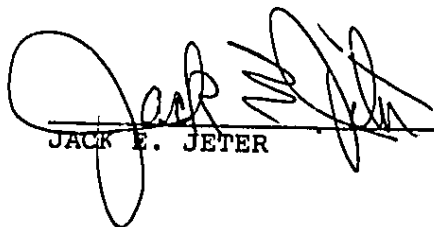

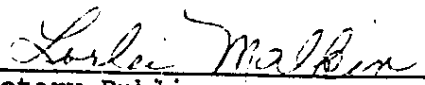
