ARTICLE ONE

NAME OF CORPORATION

The name of the corporation is NEWMAN & KROHA DEVELOPMENT CORPORATION.

ARTICLE TWO

DURATION

This corporation shall have perpetual existence commencing on the effective date of the filing of these Articles with the Department of State.

ARTICLE THREE

PURPOSE


ARTICLE ELEVEN
