# ARTICLES OF INCORPORATION OF DERMCORP, INC.

18 CRETARY OF MILLS

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

#### ARTICLE 1

#### <u>Name</u>

The name of this corporation shall be:

DERMCORP, INC.

#### ARTICLE 2

#### Principal Office and Mailing Address

The address of the principal office and the mailing address of this corporation shall be:

#### ARTICLE 3

#### Capital Stock

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100,000 shares of common stock with a par value of \$.01 per share. Each share of said stock shall entitle the holder thereof to one vote at every annual or special meeting of the stockholders of this corporation. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in promissory notes, in other property (tangible or intangible), in labor or services actually performed for this corporation, in promises to perform services in the future evidenced by a written contract, or in other benefits to this corporation at a fair valuation to be fixed by the Board of Directors. # Registered Office and Registered Agent
