The purpose for which this Corporation is organized is to engage in any and all lawful business.

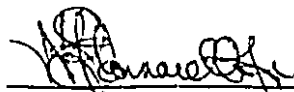

The undersigned has executed these articles of incorporation on the 13th day of June, 1995.

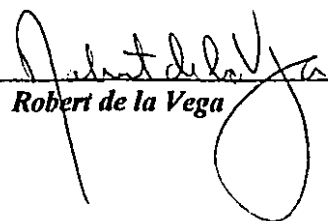
