I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter, and 1 do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation, and to that end I do by these Articles set forth:

## ARTICLE I

## NAMB

The name of the corporation shall be American Commodities Exporters, Inc.

#### DURATION

#### ADDITIONAL POWERS
