ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be D & G ENTERPRISES OF CENTRAL FLORIDA, INC.


