

The name of the corporation is W J M TILE & MARBLE, INC. The principal address of the corporation is: 58 North Cortez Drive, Margate, FL 33068.

ARTICLE TWO

The period of its duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations maybe incorporated under the Florida Corporation Act.

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
