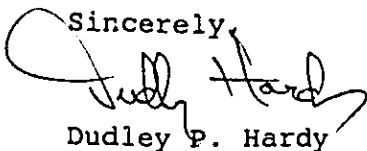

The undersigned incorporators of these Articles of Incorporation, each a natural person competent to contract, hereby subscribes themselves to these Articles of Incorporation under the laws of the State of Florida.

**ARTICLE I - NAME**

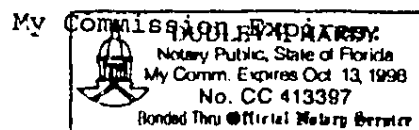
