ARTICLE I
NAME

The name of the Corporation is: DOCK OF THE BAY INVESTMENTS, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 3324 Shell Point Road West, Ruskin, FL 33570.

The principal mailing address of this corporation shall be: P.O. Box 43, Wimauma, FL 33598.

ARTICLE III
PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of restaurant and lounge.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1000). Such shares shall be of one class, and shall have a par value of One Dollar (\$1.00) per share.
