

ARTICLES OF INCORPORATION

OF

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

<u>Name</u>

The name of the Corporation shall be SIDE POCKET OF INDIAN HARBOUR BEACH, INC.

Principal Office
