

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION HORIZON HOMES, INC.

Article I of the Articles of Incorporation of HORIZON HOMES, INC. is her amended as hereinafter provided. The Corporation is filing these Articles Amendment to its Articles of Incorporation pursuant to Florida Statute Section 607,1006.

The name of the corporation prior to the effective date of this Amendment 1. is HORIZON HOMES, INC. Article I of the Articles of Incorporation of HORIZON HOMES, INC. is hereby amended to read as follows:

"ARTICLE I
