The name of this corporation is DOC & RON, INC.

ARTICLE II

This corporation shall have a perpetual existence.

The Directors of this corporation may take action by written consent, as provided by law.

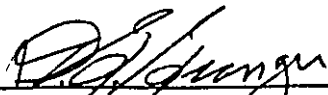
ARTICLE XI

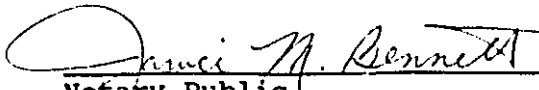

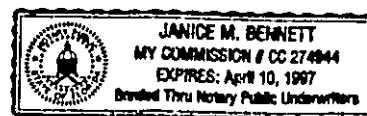

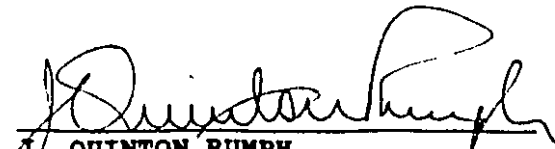
