## ARTICLES OF INCORPORATION OF

J & C RESTAURANTS, INC.

WE, THE UNDERSIGNED, hereby subscribe to the following document for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

#### **ARTICLE 1**

The name of the corporation shall be J & C RESTAURANTS, INC.

#### **ARTICLE II**

The street address of the initial principal office of this corporation is 6450 S.W. 16th Court, Pompano Beach, Florida 33068 and the name and address of the initial registered agent of this corporation is MOODY, JONES & MONTEFUSCO, P.A., 1333 S. University Drive, Suite 201, Plantation, Florida, 33324. The Board of Directors may, from time to time, move the principal office to any other address in Florida.
