I, the undersigned subscriber to these Articles of Incorporation, am a natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be **FIRST TELECOM CORPORATION, INC.**

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by the Corporation and its objectives and powers shall be to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock this Corporation is authorized to have outstanding at any one time shall be 1,000 shares of common stock at no par value. The consideration to be paid for each share shall be fixed by the Board of Directors.

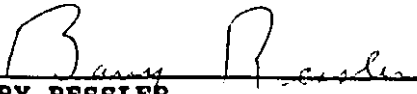
