We, the undersigned, hereby make, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

Name of Corporation

The name of the Corporation shall be JIM CASCIARI PEST CONTROL, INC., whose principal office address is 854 22nd Street, Vero Beach, FL 32960.

ARTICLE II

Purpose of Business

The Corporation is organized for the purpose of engaging in any activity permitted under the laws of the United States or of this State.

ARTICLE III

Capital Stock

The capital stock of this Corporation shall consist of 1,000 shares of common stock of \$1.00 par value, fully paid and non-assessable. 
