NAME

The name of the corporation is Hull's Jokerz Club, Inc.

DURATION



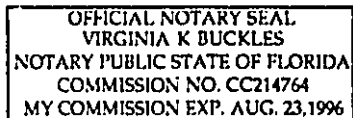


