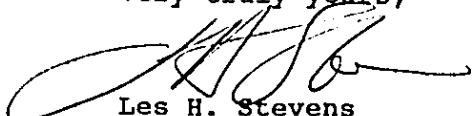

**ARTICLE I  
NAME OF CORPORATION**

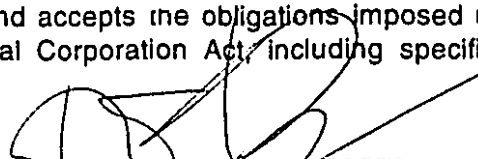

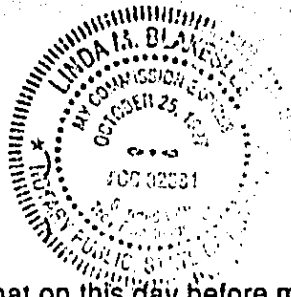
