ARTICLES OF INCORPORATION

ARTICLE I
NAME

The name of this corporation is Emmet Rhodes Fried Corporation.

The principle office of the corporation is at 1641-4 Land O'lakes Blvd., Lutz, Fl 33549.

ARTICLE II
Duration

This corporation shall exist perpetually unless dissolved according to law, commencing on the date of filing with the Secretary of State.

ARTICLE III
Purpose

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

ARTICLE IV
Capital Stock

This corporation is authorized to issue 200 shares of one dollar (\$ 10.00) par value common stock, all of which shall have the same rights and privileges.

Each share of common stock shall entitle the holder thereof to one (1) vote at any stockholders meeting and otherwise to participate in all such meetings and in the assets of the corporation, and such shares shall be fully paid and non-assessable. They shall be issued for such consideration as may be determined by the Board of Directors, which shall have a value at least equal to the full par value of such shares. They may be paid for in lawful money of the United States of America, or in property, labor or services.

ARTICLE V
Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 1641-4 Land O'Lakes Blvd., Lutz, Fl 33549.

and the name of the initial registered agent of this corporation at that address is Emmet Rhodes Fried.

ARTICLE VI
Directors

This corporation shall have two (2) director(s) initially. The number of directors may be increased or decreased from time to time by by-laws adopted by the stockholders, but shall never be less than one (1). Vacancies on the Board of Directors may be filled at any special meeting of the stockholders or at any meeting of the Directors. Directors need not be shareholders of the corporation. They may hold office after their election for a period of one (1) year, or until their successors are duly elected. The affairs of the corporation will

be managed by the Board of Directors as provided by the By-laws of this corporation.

ARTICLE VII
Initial Board of Directors
