ARTICLES OF INCORPORATION

OF

CHASTAIN COMMUNICATIONS CORPORATION

ARTICLE I. NAME

The name of the corporation is CHASTAIN COMMUNICATIONS CORPORATION.

ARTICLE II. DURATION
