ARTICLES OF AMENDMENT OF
CHASTAIN COMMUNICATIONS CORPORATION

CHASTAIN COMMUNICATIONS CORPORATION, by and through its sole officer and director adopts the following amendments:

ARTICLE I. NAME

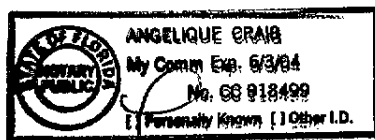
