

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby takes and adopts the following articles of incorporation:

**ARTICLE I  
NAME**

The name of the corporation is **KING'S MEDICAL IMAGING CENTER, INC.**

**ARTICLE II  
CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE III  
PURPOSE OR PURPOSES**

The general purposes for which the operation is organized are:

1. To engage in the business of leasing diagnostic imaging equipment.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.




