The corporation may transact any and all lawful business for which corporation may be incorporated under the laws of the State of Florida.

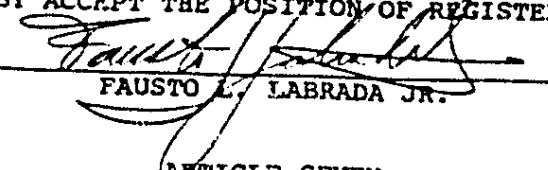
ARTICLE FIVE

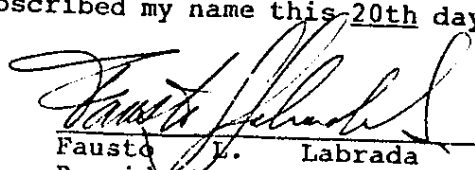
