THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE
FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPT THE FOLLOWING ARTICLES OF
INCORPORATION:

ARTICLE I - NAME

The name of this Corporation is Planning & Research Group, Inc.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the date of execution
of these Articles.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful
business.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is
5,000 shares, all of which shall be common shares with par value of \$1.00.

ARTICLE V - PREEMPTIVE RIGHTS GRANTED

Each shareholder of stock of this Corporation shall be entitled to full preemptive rights
to purchase any unissued or treasury shares of the Corporation and any securities of
the Corporation convertible into carrying a right to subscribe to or acquire shares of
any such unissued or treasury shares.
