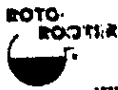

ARTICLES OF INCORPORATION
OF

ARTICLE I--NAME

The name of this corporation is SUNCOAST SEWER & DRAIN, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.




