ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS ST. MICHAEL COUNSELING CENTER, INC.

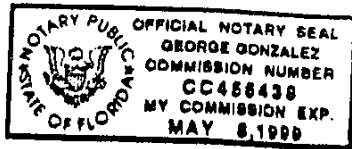

