## CERTIFICATION OF INCORPORATION OF

DAPPA PROMOTIONS INTERNATIONAL INC

We, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of an Act of the Legislature of the State of Fioridal approved June 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

FIRST: The name of the Corporation is: DAPPA PROMOTIONS
INTERNATIONAL INC

SECOND: The general nature of business to be transacted by the Corporation is as follows:

Building construction, painting, pantry and waterproofing, general labor, electrical, plumbing, trash and
garbage cleaning, site cleaning; disposal and hauling, debre
removal, landscaping and maintenance, general carpentry,
installing drapes, tile, carpet, b linds, rugs, acoustical
ceiling fans, molding, janitorial service, security services,
guards, armed and unarmed, security devices. To manufacture,
purchase, or otherwise acquire, and to own and mortgage, pledge,
sell, assign and transfer or otherwise dispose of, and to
invent, trade, deal in and with goods, wares, merchandise and
other personal and real property of every class and description
whatsoever.

To buy, seil, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitable dealt with in connection with any of the said business.

To guarantee, acquire by purchase, subscription or otherwise hold for investment, or otherwise sell, assign, transfer, mortgage, pledge otherwise dispose of the shares of the capital stock of, or any bonds, securities or evidences of indebtedness created by any other corporation or corporations of the State of Fiorida, or any other state or government, domestic or foreign, and while the owner of any such stocks, bonds, securities or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to ald by loan, subsidy, guaranty or in any other manner whatsoever so far as the same may be permitted in the case of corporations organized under the laws of the State of Fiorida, any corporation whose stocks, bonds, securities or other obligations are or may be in any manner and at any time owned, held, or guaranteed, and to do any and all other acts or things for the preservation, protection, improvement or enhancement in value of any such stocks, bonds, securities

or other obligations, and to do all and any such acts or things designed to accomplish any such burpose.

To acquire, hold, own, dispose of and generally deal in grants, concessions, franchises and contracts of every kind, to cause to be formed, to promote and to aid in any way in the formation of any corporation, domestic or foteign.

To act as financial business and purchasing squation domestic and foreign corporations, individuals, partnerships, associations, state governments and other bodies.

To acquire in any manner, utilize, enjoy, hold, sell, assign, lease, mortgage or otherwise dispose of letters patent of the United States or any foreign country, patents, patent rights, licenses and privileges, inventions, improvements and processes, copyrights, trademarks and trade names or pending applications therefor, relating to or useful in connection with any business of the corporation or any other corporation in which this corporation may have an interest as a stockholder or otherwise.

To bottow money and contract debts when necessary for the transaction of the business or for the exercise of the corporate rights, privileges or frauchises, or for any other lawful purpose of its incorporation, to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specified time or times, or payable upon the happening of a specified event or events, secured or unnecured, from time to time, for moneys borrowed or in payment for property acquired, or for any of the objects of the huslusss of the corporation) to secure the same by mortgage or mortgages, or deed or deeds of trust, or pledge or other lies upon any or all the property acquired or to be acquired; and to confer upon the holders of any debentures, bonds or other evidences of Indebtedness of the corporation, secured or unsecured, the right to convert the principal thereof into any preferred or common stock of the corporation, as now or hereafter authorized upon much terms and conditions as shall be fixed by the Board of Directors; to sell, pledge, or otherwise dispose of any or all debentures or other bonds, notes and other obligations in such manner and upon auch terms as the Board of Directors may deem Indictous, subject, however, to the provisions of Article THIRD hereof.

To acquire by purchase, subscription or otherwise, and to own, hold, sell, vote and handle shares of stock in other corporations.

To have one or more officers conduct its business and promote the objects within and without the State of Florida, in other states, the District of Columbia, the territories, possessions and dependencies of the United States, and in foreign countries, without restrictions as to place or amount. To do all and everything beceasary and proper for the accompliatment of any other the purposes or the attainment of any of the objects, or the furtherance of any of the powers enumerated in this Certificate of Incorporation or any amendment hereof, becassary or incidental to the protection and benefit of the corporation, as principal agent, director, trustee or otherwise; and, in general, either slone or in associations with other corporations, firms or individuals, to carry on any lawful business necessary or the furtherance of such purposes or objects of the corporation, whether or not such business is similar in nature to the purposes and objects as set forth in this Certificate of Incorporation or any amendment hereof.
