

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is FLAGLER STATION, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 22 day of June, 1995, being the same date as the subscription to and acknowledgment of these Articles of Incorporation.



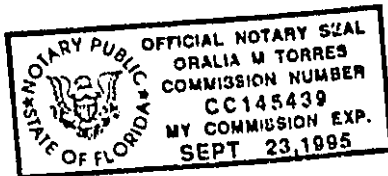


