ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, being a natural persons and competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is S & S TRACTOR INC.
