

ARTICLES OF INCORPORATION

OF

E.O. KOCH CONSTRUCTION, CO.



ARTICLE I-Name

The name of this corporation is E.O. Koch Construction, Co.

ARTICLE II- Principal Office

The address of the principal office is 3504 Office Park Road, Sebring, Florida, 33871.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock

This corporation is authorized to issue 8,000 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

ARTICLE VI-Preemptive Rights
